Supplier is encouraged to use AS9102 Forms and process for the balance of the content but supplier may use their own format as longs as requirements of QAP G are provided. Any charged FAI shall be in AS9102 format and contain all AS9102 content.
  - OT16-008 Cover Sheet (Yellow sections are mandatory, Blue are as applicable)
  - AS9102 Form 1
    - This form is used to identify the product that is having the FAI conducted on (e.g., detail part, sub-assembly, assembly); referred to as "FAI part".
  - AS9102 Form 2
    - This form is used if any materials, special processes, or functional testing is defined as a design characteristic. Actual material certificates, process certificates and test data sheets shall follow form 2. Refer to QAP G.
  - AS9102 Form 3
    - This form is used to record inspection results for the design characteristics and to document any applicable nonconformities (reference 9102, 4.4). Nonconformities shall be dispositioned on a TDSI VIR prior to the FAI being provided. The VIR number shall appear next to the nonconformance and on this coversheet Field 8 and AS9102 Form 1, Field 8.
- 2) Save the file as FAIR PN 123 Rev ABC SUPPLIER where PN 123 is the TDSI Part Number (Not the Supplier's PN), ABC is the TDSI PN part revision and SUPPLIER is the actual supplier name. Do not use any special characters such as a period, comma, #, \$, %.
- 3) Obtain TDSI portal link and account. Email <u>FAIR@Thalesdsi.com</u> to obtain link to upload the FAI package. Previous links may be pasted in your browser rather than requesting new links.
- 4) Upload the FAI package to the TDSI portal. The entire FAI must be in one file.
- 5) Provide this form with the shipment. Do not supply a printed copy of the FAI nor coupons unless specifically requested to do so.
